#### 1. Applicant Paid VIA mybackcheck.com:

- i. Candidates are directed to visit the CCA landing page www.backcheck.net/cca to start the online process. As clients, your agency will be added to the drop down menu of affiliated camps/organizations.
- ii. Candidates enter their personal details securely and verify their ID either by:
  - a) Electronic ID Verification online by answering a number of out of wallet questions placed before them, or,
  - b) Printing a completed consent form and visiting one of thousands of participating Canada Post locations across Canada (sites are identified on the website for the applicant). A Canada Post retail agent then stamps and scans the form along with the two pieces of acceptable ID, and transmits the information securely to myBackCheck.com where this is aligned to the application in progress from the applicant.
- iii. Details are forwarded to an accredited Canadian police service who conduct the checks querying RCMP repositories of information.

Within one business day the check will be completed and automatically shared with the camp. Applicant pays for the check online with credit card.

The cost to CCA/AAC affiliated organizations: \$29 (plus applicable taxes) Enhanced Police Information Check. This price includes the online electronic identification verification or if required, the Canada Post ID verification).

#### 2. Camp or Organization Paid Process:

- i. Your office representative sends an e-invitation to the candidate to complete their E-PIC.
- ii. Candidate completes the Sterling consent form and electronic ID verification on-line.
- iii.Details are forwarded to an accredited Canadian police service who conducts the check querying RCMP repositories of information. Results are made available to you within one business day.
- iv.You are invoiced for the checks on a monthly basis.

The Cost: \$29 (plus applicable taxes) per Enhanced Police Information Check.
